

**ANNUAL PLAN FLOOR FEE PAYMENT AGREEMENT**

The following is an agreement to pay Great Lakes Sword Club (GLSC) for floor fees for the 2017-2018 season. The season will begin August 1st, 2017 and terminate on July 31st, 2018. The student also agrees to pay GLSC annual dues of \$20, as well as USA Fencing Member dues, for the 2017-2018 season. USA Fencing dues must be paid prior to the first practice the member attends. Practice sessions missed due to failure to obtain proof of current USA Fencing membership will not be reimbursed. Members intending to fence with Youth Fencers under the age of 14 must obtain a USA Fencing Professional Membership due to insurance requirements.

**This also applies to parents fencing with their own children.**

GLSC will maintain club insurance through USA Fencing. A calendar of scheduled practices is available at <http://www.glswords.com>. GLSC does not refund fees if the student chooses not to attend all the available practices. Notification of closings due to inclement weather will be posted on the website and members will be notified by email.

GLSC offers the following Annual Plan Floor Fee Option:

Annual Monthly Plan (\$20 per month for all fencers): Payment is to be made monthly from September 2017 through July 2018. Payments are due by the 10th of each month or a \$5 late fee will be charged for each week the fees are delinquent. Annual GLSC dues are collected in August in addition to the monthly fees.

Individuals that choose not to participate in the Annual Plan may instead participate by paying the Monthly Walk-in Rate of \$35 per month, which is available only to GLSC members. GLSC also offers a Daily Walk-in rate of \$10 per practice session for all non-GLSC members and for GLSC members not enrolled in the Annual Plan or paying the Monthly Walk-in rate.

If a member decides to terminate their membership before the end of the season they must notify GLSC in writing indicating the termination date. Members enrolled in the Annual Plan agree to pay the difference between the Annual Plan Rate and the Monthly Walk-in Rate for each month of practice that was made available to the member by GLSC from the start of the season through the date of membership termination. Exceptions will be made for individuals with documented injuries/illness and for individuals permanently moving out of the area. This does not apply to individuals that vacation in another state for a portion of the season.

Parents/Legal Guardians must sign for members under the age of 18 years. By signing below the member, or parent/guardian in the case of minors, indicates acceptance of the conditions outlined above regarding payment for floor fees on the selected payment plan. Any disputes that arise from this agreement will be settled in accordance with the laws of the State of Michigan.
